Log in Sijilat system [www.sijilat.bh](http://www.sijilat.bh)

1. Sign In using E-Key details.
2. Update the applicant information.
3. Click on **E-services**.
4. Click on Annual Report.
5. Follow entering the Applicant Details and the CR number.
6. Enter the CR number without the branch.
7. Select the CR number.
8. Select the Application Type. "Company will be able to view a list of violations on its CR as well".
9. Select the Year, Audit Firm, Currency, Audited Status, Auditor Opinion and Type of the company activity.
10. Enter the values of the Statement of Financial Position and click Save & Continue.
11. Enter the values of the Income Statement, upload the full set of the Financial Statements, and click submit or previous in case any corrections are needed.

12. Choose communication language with MOIC employees: English or Arabic.

13. To follow up on your application after submission click E-services/Annual Report/ Annual Report Status Enquiry.

14. The System will send SMS messages to your mobile no. in the system for each action on your application.
